TERMS & CONDITIONS

GENERAL TERMS AND CONDITIONS

In order to operate the Bubble facility in a safe and efficient manner, expectations are that all users shall abide by the following terms and conditions:

1. **CONTRACT:** FULL payment is required prior to use of the Bubble facilities. All users must abide by their paid and scheduled times. That is the use of the facility is restricted to the stated time, dates and number of players listed on the payment confirmation.
2. **RE-ASSIGNMENT:** We reserve the right to re-assign booked pads as required.
3. **AS IS:** All fields/pads are rented on an "As Is" basis. This applies to suitability, condition, and service.
4. **TRANSFERABILITY:** The contracts are non-transferable without the express written consent from Bubble Operations.
5. **ADVANCE BOOKING:** Mandatory 48-hours advance booking for all requests
6. **PAYMENT:** Payment of requested time must be made the **earlier** of:
 1. 24 hours from receipt of payment request; or,
 2. 24 hours prior to use of facility;
 3. Proof of payment should be carried with you during rental time and presented to any NSGSC official upon request. Failure to present proof of payment may result in immediate expulsion from the facility at the official's discretion.
7. **REFUNDS:** All cancellations require to be submitted in writing (email to registrar@nsgsc.com) by the original requester ("Renter"). Refunds will be applicable as follows:
 - 100%** - Minimum ten (10) days written notice;
 - 50%** - Minimum three (3) days written notice;
 - 0%** - Two (2) or less days (within 48 hours of booking) written notice;
8. **MINIMUM AGE:** Children under the age of 18 must be supervised by a parent or designated adult at all times. Children as spectators are only permitted within the 50 person occupancy limit
9. **ALL PLAYERS:** The Renter shall ensure that all its players conduct themselves in an orderly manner, and comply with all statutes, regulations, by-laws and rules made under federal, provincial or municipal authority which in any way affects the use of the facility. This includes compliance with the NSGIF Usage Policy & Participant Guidelines.
10. **FIELD TIME:** All Bubble pads are to be cleared for next group **five ON THE HOUR or HALF HOUR ACCORDING TO THE RENTAL CONTRACT** – Facility clock is official time. NO Renter or members, users or guests of the Renter is permitted on any pad prior to their respective start time.
11. **NO SMOKING:** Smoking, using tobacco, or holding lighted tobacco is strictly prohibited in all areas of the Bubble and Within the confines of the fenced area. (School Board policy prohibits smoking on School Board Property.)

12. **NO ALCOHOL:** Consumption of alcohol is strictly prohibited in all areas inside and outside of the Bubble.
13. **NO** food or beverages are allowed in the facility – WATER ONLY
14. **NO** spitting is permitted inside the Bubble.
15. **NO** metal or screw-in cleats are permitted to be used on the Bubble turf.
16. **NO** pets allowed (unless it is a licensed disability assistance dog).
17. **ALL** Trash and water bottles to be removed and placed in receptacle (Bylaw #7792).
18. **EMERGENCY EXITS:** All fire exits, hydrants, doors or any other marked areas must be kept clear of benches and nets. Anyone activating the emergency alarm or sprinkler system without cause will be required to pay for damages / lost revenue and may face criminal charges.
19. **UNAUTHORIZED EQUIPMENT:** Any non-soccer equipment, bicycles, skateboards, scooters, etc. are strictly prohibited inside the Bubble without prior written consent from the Bubble Operations.
20. **SPECTATORS:** The Bubble has limited space and is not configured for spectators. Consequently, any and all non-playing individuals must remain on the perimeter of the Bubble playing field and not permitted on the playing field. Spectators count as part of the facility's 50 person maximum occupancy limit.
21. **LOST AND FOUND:** The NSGSC and associated divisions accepts no responsibility for any theft and/or damage to any personal possessions left in the Bubble.
22. **LIABILITY:** All Renters of the facility shall indemnify and save harmless the NSGSC and its employees and members against all liability, claims, damages, or expenses due to, or arising out of, any act or neglect by the Renter, or members, users and guests of the Renter, on or about the facility, or due to, or arising out of, the entry or use of the facility, including liability for injury or damages to the persons or property of the Renter, or members, users or guests of the Renter.
23. **FAILURE TO COMPLY:** Failure to comply with any of the above terms and conditions will result in expulsion and loss of future rental privileges.
