Special Report – Club Licensing & Player Pathway

- The issue we have been denied opportunity to offer top level of play Premier
- In our club we have Impact, Renegades, D1
- If you want to play premier need to go to club offering that NS is NVFC
- Reviewed the club licensing journey started in 2019; final decision June 2024
- Worked in collaboration with NVFC; then decided to pursue on our time; had TD replacement processes in between. Fall of 2023 worked on cleaning up all that CSA asked club. In spring, CSA says YES, BC Soccer says NO. Only clubs that have both males/females can participate in BCSPL.
- Why does it matter? NSGS stands for our players where all girls and women can play for life
- We deserve the right to play at the highest level
- We deserve the National Youth Club License and to play in the BCS Premier League
- What now put trust into club to make it right for our players; honor our values and demand equitable pathway opportunities for our girls
- Continue to collaborate with NVFC; be leaders and deliver excellence in development programs, coaching and inclusive opportunities for NSG players and those players seeking a higher level of play in the NSYSA District

- Registration overall growth

- Rentals we can't keep up we rent out 15 hours a day 7 days a week; open on holidays, Christmas day etc.
- Renewed sponsorship
- Touraments TGT no longer viable and had to be cancelled
- Last year pivoted and did two indoor tournaments New Years and Easter both successful.

Expenses

- Bank fees
- Development
- Equipment significantly over budget incurred costs due to ending Macey's relationship (issues with shorts etc); investment into new equipment ie pug nets for all teams; ongoing replacement of equipment (goalposts etc) inside bubble due to increase in retnt
- Events & awards no coaches socials
- Facilities, fields and operations expenses run tightly
- Professional fees external contractors and legal service required to support crisis comms and NYCL application
- Salaries increased ref rates and additional headcount
- Tournaments more select level teams participating in tournaments and provincial competitions that are partially funded by the club.
